Benefits to Enrich Your Life

Educational

- **Catholic Elementary School Scholarships¹** - \$200 scholarships (renewable annually)
- **Catholic High School Scholarships¹** - \$500 scholarships (renewable annually)
- **College and University Scholarships¹** - \$500 or \$1,000 non-renewable scholarships—amounts vary based on attendance at a two-year or four-year college.

Spiritual

- **Sacramental** - Baptism, First Communion and Matrimony are recognized with a commemorative gift.
- **Seminarian Scholarship** - Members who have made this spiritual commitment are eligible to receive a scholarship grant.
- **Retreat Reimbursement** - Up to \$100 benefit to be used toward the cost of an annual Catholic retreat or in celebration of the sacrament of confirmation.
- **Camp Reimbursement** - Up to \$100 benefit annually for children to attend Catholic summer camp.
- **Prayer Network** - Members' prayer intentions are submitted to our online prayer network, cfl.org/prayer and are remembered during masses in the All Saints Chapel in the Milwaukee office.

Wellness

- **Prescription Savings** - Discounts on prescriptions, lab tests, vision care and hearing aids, plus medication management tools and grocery guidance.
- **Medic Alert** - Free first-year membership including the cost of a stainless steel identification bracelet or necklace.
- **Pet Insurance** - Members are eligible for a discount on pet insurance premiums each year.

Financial

- **Orphan Benefit²** - A monthly living allowance of up to \$350 for orphaned children and \$4,000 per year for up to four years of college expenses.
- **Child Protection Benefit²** - Members may apply for \$15,000 in Value Life protection for their uninsurable or at-risk child between the ages of 60 days old through age 17. Coverage will be guaranteed without underwriting, subject to benefit qualifications.
- **Norton™ 360 with LifeLock** - Members can receive a 35% first-year discount on membership with one of the most trusted identity theft protection providers.
- **Member Rewards Program** - Members can save up to 70% at hundreds of national and local merchants, such as Best Buy, Great Wolf Lodge, GrubHub, Universal Studios Theme Parks, Costco, and more.
- **Special Needs** - A member or child of a member challenged by physical or cognitive disabilities is eligible to receive reimbursement of up to \$100 annually toward the cost of a therapy program, summer camp or the purchase of an adaptive device.
- **Estate Planning** - Members are eligible for a one-time reimbursement of up to \$50 for the preparation or updating of a will or estate plan.
- **Financial Wellness Hub** - Take control of your financial future with educational tools that will help you make wise financial decisions for you and your family.
